#### Family Cap:

- Money previously applied to the Family Cap program will be applied across all sports going forward. Therefore, beginning with the 2022-23 school year, the Family Cap program no longer exists within the Athletic Department.
- As stated prior in this document, Scholarships are available through the Scholarship Application process.

#### **Refunds:**

- Full reimbursement will be provided when a student-athlete withdraws from a sport prior to the first day of that athletic season. The first day of practice / tryouts for each sport can be found on the Athletic Section of the HWRHS Web Site under "Registration Information."
- Student-athletes who do not make a team within the program after the tryout period will be eligible for a full refund.
- Students-athletes who move out of the district during a season will be eligible for a prorated refund.
- Student-athletes who are unable to participate in an activity because of illness or injury (physician's statement required) will be eligible to receive a prorated refund.

### Examples of situations when a refund will not be provided:

- A student-athlete is dismissed from a team due to disciplinary issues.
- A student-athlete is placed on a non-desired level within the program as compared to a desired level (at any time during the season). This situation does not constitute the student-athlete being "cut" from the program.
- A student-athlete is deemed ineligible to compete because they do not meet MIAA and/or HWRHS academic eligibility requirements.
- A student-athlete withdraws from a team after the first day of practice.

### HWRSD Athletic User Fee Guidelines and Procedures:

It is the practice of the Hamilton-Wenham School District to charge an athletic User Fee to each studentathlete who participates on a High School athletic team. User Fees must be collected prior to the beginning of participation for a student-athlete unless a waiver or other relief is provided.

Athletic registrations and associated User Fees will be collected on-line, through the Family ID registration portal, during the applicable registration period as established by the Athletic Director.

**Scholarship Application:** An application for financial scholarship is available on the Athletic section of the HWRHS website under the "Athletic Guidelines and Forms" link and must be submitted prior to the beginning of participation for a student-athlete to the High School Building Principal.

The Principal will evaluate the completed form and will determine if the student-athlete is eligible for a Scholarship. For those who do not have access to the internet, please contact the athletic office for copies of the application.

Athletic Operating Budget: The approved Operating Budget for FY23 includes funding that covers approximately 62% of the total costs of the High School Athletic Program.

**Tiered Approach:** Beginning in FY23 Athletic Fees will have a tiered approach. Each year's athletic costs will determine the fees of various sports within the tiers. Tier 1 is Hockey. Tier 2 is Football and Gymnastics, and Tier 3 contains all other sports.

(\*) Please note, should ski be fully approved in the 2022-23 year, families would be 100% responsible for the cost of this program for this year. The approval process will occur after the budget was complete and, therefore, families are fully responsible for this school year's ski fees.

(\*) Please also note, MySchoolBucks charges a 4.95% fee for online payment that will be added to these amounts for all users, regardless of the method of payment.

### **Team Travel: Hamilton-Wenham Athletics**

**Team Travel to Away Games**: Hamilton-Wenham will provide a bus for each away game on the schedule. Regardless of the day, time, and location of the game, the bus will leave from the High School. Each student-athlete and student manager is required to ride the team bus to all away games on the schedule.

Any rare exception to this policy requires signed approval by the Athletic Director on the Head Coach's "Away Contest Information Sheet." While students are never allowed to drive themselves to an Away Contest in any circumstance, it is possible, through this rare exception process, for parents to drive their child to an Away Contest.

At the Conclusion of Away Games: Though it is best for team unity and cohesion that players ride the bus back to Hamilton-Wenham after school, Parents / Guardians of students may take their son/daughter home from Away Contests provided they sign the Head Coach's "Away Contest Information Sheet" at the conclusion of the away contest. The process would be for the Parent/Guardian to approach the coach at the conclusion of the game and sign the form, which the coach will have available.

Special Note: Parents/Guardians may NOT take home somebody else's child.

Special Note: Busses will return to Hamilton-Wenham and will not stop at an individual player's house.

**Special Note:** Thirty (30) minutes after the conclusion of the day's activities or thirty (30) minutes after a team returns home, students will be asked to leave the school building. It is incumbent upon parents / guardians to be responsible for picking up their children within this time frame.

Away Scrimmage Contests and Other Non-Traditional Home Sites: There are occasions when a team has a legitimate need (away scrimmages, credible off site practice facilities) to travel off site without the budget to cover a bus. On these occasions, it is permissible for parents to drive a group of students, provided each student-athlete's parent sign the "Athletic Travel Permission Form." These forms are to be turned in to the Athletic Director prior to departure. All such trips will both begin and end from Hamilton-Wenham Regional High School.

**Travelling to Traditional Home Site, Off Campus:** Though good common sense should always prevail, any parent can drive a "group" of players to a traditional home site that is off campus. Additionally, provided all MA driving rules are followed, any student-athlete may drive to a traditional home site that is off campus as well. Following the day's practice, game, or team event, there is not a requirement to return to Hamilton-Wenham Regional High School before travelling home.

Definition of Vaping	Vaping is the act of inhaling and exhaling aerosol produced by an e-cigarette. Nicotine is delivered through vaping devices.
Addiction	<ul> <li>* 90 percent of Lifelong Smokers begin before Age 18.</li> <li>* Because addiction is a form of learning, adolescents can become addicted more easily than adults. The adolescent brain is not fully developed until age 25</li> <li>* The nicotine in e-cigarettes and other tobacco products can also prime the adolescent brain for addiction to other drugs.</li> </ul>

### "SAC" Concussion Management Parental Consent Form

**Standardized Assessment of Concussion** (SAC) is a neurocognitive evaluation/ test which allow healthcare providers to assess mental and motor status following a concussion in sports. Often even when the physical examination returns to normal in a concussed athlete, there still can be significant cognitive deficits that go undetected. Additional concussions that occur before the brain has had a chance to heal may be a mechanism for permanent damage to neural structures rarely, repeat concussions before full healing has occurred can be catastrophic.

SAC is considered one of the industry standards for such assessment and has a thorough research history to back it up. It is used all over the country by professional, college and high school sports programs to assist in evaluating when neurocognitive function has returned to normal after a concussion.

The testing process is straightforward; an athlete takes a 5 minute baseline test that the athletic trainer uses to establish baseline cognitive function during pre season. If a concussion occurs, a post injury test can be given and repeated if necessary to determine when this function returns to the normal baseline measures from the pre test.

Some of the cutting edge research in this area is now indicating that the adolescent brain actually takes longer to heal than an adult after a concussion. This is why we feel strongly that this program might help improve the management of these sports concussions at HWRHS. ### Massachusetts Law - Chapter 269, Section 18

Duty to Report Hazing

Whoever knows that another person is the victim of hazing as defined in section seventeen and is at the SCENE of such crime, shall, to the extent that such person can do so without danger or peril to himself or others, report such crime to an appropriate law enforcement official as soon as reasonably practicable. Whoever fails to report such crime shall be punished by a fine of not more than one thousand dollars. Added by St. 1985, c. 536; amended by St. 1987, c. 665.

### Massachusetts Law - Chapter 269, Section 19

Statutes to be Provided to Student Groups; Compliance Statement and Discipline Policy Required

Each institution of secondary education and each public and private institution of postsecondary education shall issue to every student group, student team or student organization which is part of such institution or is recognized by the institution or permitted by the institution to use its name or facilities or is known by the institution to exist as an unaffiliated student group, student team or student organization, a copy of this section and sections seventeen and eighteen; provided, however, that an institution's compliance with this section's requirements that an institution issue copies of this section and section seventeen and eighteen to unaffiliated student groups, team or organizations shall not constitute evidence of the institution's recognition's or endorsement of said unaffiliated student groups, teams, or organizations. Each such group, team or organization shall distribute a copy of this section and sections seventeen and eighteen to each of its members, plebes, pledges or applicants for membership. It shall be the duty of each such group, team, or organization, acting through its designated officer, to deliver annually, to the institution an attested acknowledgment stating that such group, team, or organization has received a copy of this section and sections seventeen and eighteen, that each of its members, plebes, pledges, or applicants has received a copy of sections seventeen and eighteen, and that such group, team or organization understands and agrees to comply with the provisions of this section and sections seventeen and eighteen.

Each institution of secondary education and each public or private institution of post-secondary education shall, at least annually, before or at the start of enrollment, deliver to each person who enrolls as a full-time student in such institution a copy of this section and sections seventeen and eighteen. Each institution of secondary education and each public or private institution of post-secondary education shall file, at least annually, a report with the regents of higher education and in the case of secondary institutions, the board of education, certifying that such institution has complied with its responsibility to inform student groups, teams or organizations and to notify each full-time student enrolled by it of the provisions of this section and sections seventeen and eighteen and also certifying that such policy has been set forth with appropriate emphasis in the student handbook or similar means of communicating the institution's policies to its students. The board of regents and, in the case of secondary institutions, the board of education shall promulgate regulations governing the content and frequency of such reports, and shall forthwith report to the attorney general any such institution which fails to make such report. ### Hazing Information: Hamilton-Wenham Athletics

At the beginning of every season, there is a required parent-student meeting with the Athletic Director and each team's Head Coach. There will be a meaningful presentation regarding hazing and parents, coaches, and student-athletes are responsible for the content of that meeting.

Hamilton-Wenham cares deeply for the individual needs and concerns of not only its athletic teams, but also the individual student-athletes that make up these teams. Great teamwork requires trust, belief in one another, and sense of community. Despicable acts of hazing do nothing to promote these values that are at the core of educational athletics.

Hamilton-Wenham will maintain and enforce a zero tolerance policy to any acts of hazing as defined herein.

Therefore, as required by Massachusetts Law, we are making the following information available.

### Massachusetts Law - Chapter 269, Section 17

Crime of Hazing, Definition, Penalty

Whoever is a principal organizer or participant in the crime of hazing, as defined herein, shall be punished by a fine of not more than three thousand dollars or by imprisonment in a house of correction for not more than one-year, or both such fine and imprisonment.

The term *hazing* as used in this section and in sections eighteen and nineteen, shall mean any conduct or method of initiation into any student organization, whether on public or private property, which willfully or recklessly endangers the physical or mental health of any student or other person. Such conduct shall include whipping, beating, branding, forced calisthenics, exposure to the weather, forced consumption of any food, liquor, beverage, drug or other substance, or any other brutal treatment or forced physical activity which is likely to adversely affect the physical health or safety of any such student or person, or which subjects such student or other person to extreme mental stress, including extended deprivation of sleep or rest or extended isolation.

Notwithstanding any other provisions of this section to the contrary, consent shall not be available as a defense to any prosecution under this action. Added by St. 1985, c.536; amended by St. 1987, c.665.

### March 2016 - Massachusetts Law Addressing the Opioid Epidemic

### MIAA Bona Fide Team Rule

The Bona Fide rule requires that members of a school team actively participate in all team practices and competitions. Members of a school tem are precluded from missing a high school practice or competition in order to participate in a non-school event/activity in any sport recognized by the MIAA.

#### **HWRHS** Attendance Policy

Student-Athletes are ineligible to participate in athletics on a day that they are absent. If they are absent on a Friday, they are not allowed to participate over the weekend in any way with their teams.

Students who come to school late for any unexcused reason, are ineligible to participate on that day.

### **Chemical Health Policy**

From the earliest fall practice date, to the conclusion of the academic year or final athletic event (whichever is the latest), a student shall not, regardless of the quantity, use, consume, possess, buy/sell, or give away any beverage containing alcohol; any tobacco product; marijuana; steroids; or any controlled substance. This policy includes products such as "NA or near beer." These penalties carry over to the next school year.

#### **USER FEE Refunds**:

- Full reimbursement will be provided when a student-athlete withdraws from a sport prior to the first day of that athletic season. The first day of practice / tryouts for each sport can be found on the Athletic Section of the HWRHS Web Site under "Registration Information."
- Student-athletes who do not make a team within the program after the tryout period will be eligible for a full refund.
- Students-athletes who move out of the district during a season will be eligible for a prorated refund.
- Student-athletes who are unable to participate in an activity because of illness or injury (physician's statement required) will be eligible to receive a prorated refund.

#### Examples of situations when a refund will not be provided:

• A student-athlete is dismissed from a team due to disciplinary issues.

• A student-athlete is placed on a non-desired level within the program as compared to a desired level (at any time during the season). This situation does not constitute the student-athlete being "cut" from the program.

• A student-athlete is deemed ineligible to compete because they do not meet MIAA and/or HWRHS academic eligibility requirements. • A student-athlete withdraws from a team after the first day of practice.
